**NATIONAL COUNCIL OF JEWISH WOMEN'S VICE PRESIDENT
ON MURPHY'S TRANSITION TEAM**

National Council of Jewish Women Bergen County Section is proud to announce that Elaine K. Meyerson, Vice President of Administration, has been appointed to serve on the Human and Children Services Committee of Governor-Elect Philip Murphy's Transition2018 Team. Governor-Elect Murphy has said that, "Transition2018 will prepare my administration for the task at hand, creating a stronger, fairer economy for all New Jerseyans."

A Vice President of NCJW since June 2017, Ms. Meyerson is responsible for all administrative functions of the organization. She is currently focusing on expanding and modernizing its technical and database capabilities. She also volunteers at the Waiting Room, a NCJW community service that provides a safe, welcoming haven at the Bergen County Courthouse for domestic violence litigants who are awaiting court appearances.

Ms. Meyerson is President of EKM1 Consulting, LLC, a non-profit consulting company, and is currently the Interim Executive Director of the NJ Coalition to End Domestic Violence (NJCEDV). Previously she was the Executive Director of the Center for Hope and Safety (formerly Shelter Our Sisters) for more than 29 years. CHS is a leading Bergen County non-profit agency providing services for victims of domestic violence.

This is not the first Transition Team on which Ms. Meyerson has served, having previously been appointed as a Transition Team Member for James Tedesco, Bergen County Executive. She has been active on many state and local human service committees and coalitions, was a former Chairperson and member of Bergen County's Human Services Advisory Committee, and has served on many advisory boards throughout her career. A noted speaker, former adjunct professor and multi-award recipient, she is a graduate of SUNY Buffalo where she received both a Masters of Social Work (MSW) and a Bachelors in Psychology and Sociology. She also holds certifications from the Academy of Certified Social Workers (ACSW).

A resident of Hillsdale, Ms. Meyerson is married for 42 years to Lawrence N. Meyerson, a former Municipal Judge and Hillsdale Councilman, and noted attorney who practices in Montvale. She has two adult children, Rachel and David and a daughter-in-law Elizabeth.
